#### Aim of the study

This study aims to investigate the impact of the EYFDM podcast and other educational podcasts on the personal lives and careers of GPs in training and those with less than five years' experience. It will also examine how the attractiveness of general practice to future doctors can be influenced, also with regard to the potential recruitment of new specialists in general practice.

#### Measures as part of the study

The first episodes of the new EYFDM podcast will be published in 2024. Study participants are all doctors who are members of EYFDM and have agreed to the privacy policy. Each participant will have the opportunity to listen to the same podcast episodes on public podcast platforms. There will be a quantitative online questionnaire. Qualitative questions may be sent by email after the questionnaire has been approved by the participants.

#### **Conditions of participation**

1. You agree that we may merge data from different surveys in a pseudonymised form. For this purpose, we use individual identification features that cannot be traced back to you personally (e.g. initials + month of birth).

2. You agree that, if you have voluntarily provided your email address, it may be used to make enquiries and to evaluate them pseudonymously.

3. All data will be stored anonymised (without email address) for ten years. Only the research team has access and uses it only for internal research purposes. At no time will it be passed on to other persons, other lecturers or third parties.

4. If you **do not** wish to agree to any of the above points, you will not suffer any disadvantages.

#### Participation can be cancelled at any time without any adverse consequences.

### Voluntary participation and cancellation rights without negative consequences

Participation in this study is voluntary. Participants can withdraw their consent at any time without giving reasons and without any disadvantages. In the event of withdrawal, the deletion of the data collected up to that point can be requested, provided that there is no legal documentation or reporting obligations to the contrary.

#### **Data protection**

The data protection regulations are complied with in the context of this study. It is pseudonymised data sheets are collected and processed without mentioning names. The Pseudonymisation takes place via individually created pseudonym abbreviations. The email address is used for voluntary respondent enquiry and then deleted and replaced by a numerical code. replaced. The pseudonymised data is only stored on the university's internal servers and stored on computers. Third parties do not have access to the original documents. The data collected during the study will be stored for 10 years after the end of the study. The data will not be passed on to third parties. The data will remain in the European Union at all times. After 10 years, the data will be irrevocably deleted.

## Data protection according to GDPR

The legal basis for data processing is your consent (Art. 6 (1) (a) and Art. 9 (2) (a) of the European General Data Protection Regulation). The controller within the meaning of the General Data Protection Regulation is: Mrs Partzsch. Participants have the right to request information about the data stored by us within the framework of the legal requirements. They can also request the correction of incorrect data, the transfer of the data they have provided, the deletion of the data or the restriction of its processing.
